IMPORTANT ELECTRICAL CONDITIONS AND REGULATIONS

1. Each 110 / 120V service connection is 1 cord with 1 outlet. Vendors are not allowed to share their electrical service with another booth.

Under no circumstances shall anyone other than a Convention Complex electrician make electrical connections into the floor plates or disconnects. Exhibitor will be fined and charged for any damages resulting from attempting to install their own service.

3. Walls, columns and permanent building utility outlets are not a part of booth space and are not to be used unless specified otherwise by building management.

4. Claims will not be considered unless filed by exhibitor prior to close of exhibition.

5. All exhibitor's cords must be of the 3 wire grounded type. All exposed non-current carrying metal parts of fixed equipment, which is liable to be energized, shall be grounded and U.L. listed.

6. Rates quoted for all connections cover only the bringing of the service to the booth in the most convenient manner and does not include connectiong equipment or special wiring.

7. All electrical service comes from floor utility boxes. (No overhead installation.) Only BJCC electricians are allowed in the utility boxes.

8. Labor for utility work on equipment, including repairs, tracing malfunction, hook-ups, and working on the equipment can be provided by the Convention Complex electrician at the prevailing rate.
