Southern Farm Show Exhibitor Insurance Requirements.

As outlined in the exhibitor kit, exhibitors in the Southern Farm Show are required to provide an insurance certificate covering liability for exhibit contents, personnel and show guests within the exhibit space. The certificate should list Zimmerman Expositions LLC as an additional insured.

The insurance limits on the certificate should be a minimum of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate. Please use the sample insurance certificate on page two as a guide when requesting a certificate from your insurance agent.
