 - b. Food items limited to "bite size" (1 oz. or less).
- 3) Use of cooking equipment must have prior approval of The Savannah International Trade & Convention Center. ***Sampling Company must comply with all state and local fire and health codes.
- 4) Exhibiting Company is responsible for securing a City/County of Savannah Health Permit. Permits must be obtained in order to distribute food and beverages. - 7) The applicant named below acknowledges they have sole responsibility for use, service, and disposition of such items in compliance with all applicable laws. State law prohibits the sampling and distribution of alcoholic beverages.
